Procedures & Terms and Conditions

Procedures of DR-2X Installation Support Program with FREE LAN-01A:

1. Complete the Application Form of "DR-2XE Installation Support Program" after the installation/ purchase of a new DR-2XE with FREE LAN-01A.
2. Submit the Application Form to the YAESU authorized distributors or dealers from whom you purchase the new DR-2XE.
3. YAESU authorized distributors handle the "DR-2XE Installation Support Program." Please ask YAESU authorized distributors or local dealers, for any detailed benefits of the program.

Procedures of DR-1X Trade-In Program:

1. Complete the Application Form of "DR-1XE Trade-In Program" after the installation/ purchase of a new DR-2XE with FREE LAN-01A.
2. Submit the Application Form to the YAESU authorized distributors or dealers from whom you purchase the new DR-2XE.
3. Make sure with dealers from whom you purchase a new DR-2XE to which of YAESU authorized distributors you should contact and ship your existing DR-1XE for "trade-in."
4. Within 30 days after installation of a new DR-2XE, ship your DR-1XE to the YAESU authorized distributor by insured carrier. It is highly recommended that you contact the YAESU authorized distributor before you ship the existing DR-1XE. Shipping cost must be incurred by customers.
5. YAESU authorized distributor shall confirm the appearance and operation of your DR-1XE. When it is not in reasonable condition for the "DR-1XE Trade-In Program," YAESU authorized distributor may return your DR-1XE to you.
6. When your DR-1XE is in reasonable condition for the "DR-1XE Trade-In Program," the payment of EUR300/ GBP270 shall be arranged to your bank account from Yaesu UK Ltd. Payment shall be processed 6 to 8 weeks after receiving your DR-1XE by Yaesu UK Ltd. from distributors.

**Customers in UK may return the DR-1XE directly to Yaesu UK Ltd. For details, please contact the dealer from whom you purchase the new DR-2XE.*

Terms and Conditions:

1. "DR-2XE Installation Support Program with FREE LAN Unit" and "DR-1XE Trade-In Program" are valid from July 1 to December 31, 2018.
2. "DR-2XE Installation Support Program with FREE LAN Unit" and "DR-1XE Trade-In Program" are valid for customers who purchase a brand new DR-2XE (CE model) from the YAESU authorized distributors or dealers in Europe and UK ONLY. Per 1(one) unit of the installation of the new DR-2XE, 1(one) unit of DR-1XE Trade-In can be claimed.
3. Amount of cashback for a returned DR-1XE is EUR300/ GBP270. ("DR-1XE Trade-In Program")
4. Customers must send the claim of "DR-1XE Trade-In Program" with the claim of "DR-2XE Installation Support Program" and return an existing DR-1XE to the YAESU authorized distributors within 30 days after the purchase of a new DR-2XE. Even if the customers who purchase a brand new DR-2XE send the claim of "DR-1XE Trade-in Program" after the claim of "DR-2XE Installation Support Program" has been done, the trade-in claim shall not be acceptable.
5. Shipping Cost of a returned DR-1XE must be incurred by customers. ("DR-1XE Trade-In Program")
6. Payment method of cashback is electronic transfer to customers' bank account. Payment shall be processed 6 to 8 weeks after receiving customers' DR-1XE by Yaesu UK Ltd. ("DR-1XE Trade-In Program")
7. Yaesu UK Ltd. shall not be liable for any VAT, Bank or Building Society processing or administration fee associated with this program. ("DR-1XE Trade-In Program")
8. "DR-1XE Trade-in Program" may be void where taxed, restricted or prohibited by local country regulations.
